What is MIST?

The Manufacturing Industrial Safety Training (MIST) is an eLearning course designed by the Manufacturers' Health & Safety Association (MHSA). The course serves as a general introduction to safety for new workers in the manufacturing industry or as an important refresher.

Why was MIST created?

Health and safety are two vital components of every worksite. To maintain a healthy and safe work environment, all workers must understand their roles and responsibilities. This course introduces the participant to the Alberta Occupational Health and Safety (OHS) Act, Regulation, and Code, health and safety responsibilities in the workplace and how this information can be used for a healthy and safe worksite



What is included in the course?

This online Manufacturing and Industrial Safety Training course is composed of 12 sections. These sections include:

- Section 1: Benefits of a Health and Safety System
- Section 2: Hazard Assessments
- Section 3: Hazard Controls
- Section 4: Health and Safety Committee/Representatives
- Section 5: Training and Competency
- Section 6: Other Parties
- Section 7: Preventative Maintenance
- Section 8: Worksite Inspections
- Section 9: Incident Investigations
- Section 10: Emergency Preparedness
- Section 11: First Aid
- Section 12: Management Commitment and Involvement



Upon completion, you will be presented with a final scenario to test your knowledge.

What is the length of the course?

This self-paced online course will take approximately 2.5 hours to complete. It is 150 minutes in total.

What is the cost?

MIST training is available through BIS Trainer at a cost of \$39.95 per person.

Do I need a BIS Trainer MHSA student account prior to sign up?

It is not necessary to have a pre-existing BIS Trainer account to access MIST. If you do not already have an account, you will be prompted to create a new account to purchase MIST. Refer to <https://www.youtube.com/watch?v=wfJ6Bi6r0p4&t=18s> on how to purchase courses through BIS Trainer.

If I do have a BIS Trainer account will this automatically add to my student profile?

Yes, upon completion of MIST, a certificate of completion will be added to your profile under course registrations. From here, the record can be downloaded, saved and/or printed.

Is MIST training mandatory in the manufacturing industry?

MIST is not mandatory for workers to complete. It is a legislated requirement for workers to understand their obligations and responsibilities for health and safety in the workplace. MIST covers a variety of general health and safety information that workers would benefit from greatly. Employers should establish minimum requirements of training. Consider incorporating MIST into your employee orientation process!
